DIRECT DUES PAYMENT FREQUENTLY ASKED QUESTIONS

WHY ARE WE CHANGING THE WAY WE PAY OUR UNION DUES?

• WHEN WE SIGN OUR NEW CONTRACT IN 2016, THE SCHOOL DISTRICT WILL NOT BE ABLE TO DEDUCT UNION DUES FROM OUR PAYCHECKS.

WHEN WILL PAYROLL DEDUCTION STOP AND DIRECT PAYMENT BEGIN?

• WE WILL BEGIN DIRECTLY COLLECTING DUES IN SEPTEMBER OF 2016. OUR GOAL IS TO COMPLETE ENROLLMENT FOR ALL OUR MEMBERS BY JUNE 2016.

HOW MUCH ARE MY UNION DUES?

• ONE HOUR OF YOUR WAGE FROM EVERY PAYCHECK. FOR EXAMPLE, IF YOUR HOURLY WAGE IS \$11.76, YOU PAY \$11.76 FROM EVERY PAYCHECK YOU RECEIVE.

WILL I STILL PAY DUES EVERY TWO WEEKS?

• PAYMENTS COULD BE EVERY TWO WEEKS, ONCE PER MONTH OR ONCE PER YEAR.

WILL MY DUES AMOUNT CHANGE?

• THE AMOUNT YOU PAY IN DUES WILL ONLY CHANGE IF MEMBERS VOTE FOR THE DUES AMOUNT TO CHANGE.

DO I HAVE TO PAY UNION DUES?

• OUR NEW CONTRACT WILL NOT REQUIRE YOU TO BECOME A MEMBER OF THE UNION, BUT IF YOU DO NOT JOIN, YOU WILL NOT BE ABLE TO VOTE ON ANY ISSUE PRESENTED TO THE MEMBERS, INCLUDING VOTING TO RATIFY OUR CONTRACT.

WHY SHOULD I PAY UNION DUES?

• YOUR UNION DUES HELP PAY FOR THE COST TO NEGOTIATE AND DEFEND YOUR CONTRACT.

WHAT IF I DON'T PAY UNION DUES?

• YOUR CONTRACT WILL CONTINUE TO BE NEGOTIATED BY YOUR FELLOW UNION MEMBERS AND WILL CONTINUE TO PROTECT YOUR JOB SECURITY, WAGES, BENEFITS AND WORKING CONDITIONS. YOUR CONTRACT WILL CONTINUE TO PROVIDE YOU WITH PAID SICK TIME, VACATION TIME, PER-SONAL BUSINESS DAYS, PAID HOLIDAYS AND MANY OTHER BENEFITS.

WHAT OTHER BENEFITS DO I GET FROM PAYING UNION DUES?

• THE DUES YOU PAY PROVIDE FOR A FULL TIME PRESIDENT TO REPRESENT AND DEFEND YOUR CONTRACT, AND FOR THE BENEFITS AND SUPPORT OF OUR AFFILIATION WITH AFT MICHIGAN AND AFT NATIONAL.
