The meetings have begun! The various classification meetings that we had during the fall and the suggestions we heard from you during those meetings are being presented on your behalf to district representatives. April 6 was the first meeting and the discussions focused exclusively on Secretarial concerns. Our bargaining team, along with members of the Secretarial classification, engaged in a very productive conversation with our counterparts. Our team felt that we were able to share our concerns and the responses we received were promising. On April 12, our meeting focused on issues related to the Special Education Paras. This meeting was also quite productive with the district representatives finding many of our suggestions and ideas worth implementing. Some of the ideas we proposed are already being implemented and will, hopefully, be ready for the next school year. On April 26, another two classifications will meet with the district: GSRP Parapros and Technology Support Analysts. On May 1. Trades and Grounds will meet. We still have more classifications that will be scheduled for meetings, but this is where it currently stands.
